AFFIDAVIT OF STATUS

Before me, the undersigned authority, personally appeared James Jones, who being by me duly sworn, deposed as follows: "I, James Jones, a man, am over the age of consent, am a creation of God-Almighty and a follower of God's laws first and foremost, and the laws of man when they are not in conflict (Leviticus 18:3,4). Pursuant to Matthew 5:33-37 and James 5:12, let my yea be yea, and my nay be nay, as supported by Federal Public Law 97-280, 96 Stat. 1211 - "Whereas the Bible, the Word of God, has made a unique contribution in shaping the United States as a distinctive and blessed nation and people" and "Whereas Biblical teachings inspired concepts of civil government that are contained in our Declaration of Independence and the Constitution for the United States of America" and "Whereas... the Bible is "the rock on which our Republic rests". I have personal knowledge of the matters stated herein and hereby asseverate, understanding both the spiritual and legal liabilities of, "Thou shalt not bear false witness against thy neighbor". I have created this Affidavit to establish the true facts of my status, as there or those who are attempting to force a status on me that is not mine, for their unlawful financial gain. I declare, under the penalty of perjury and under the laws of the United States for America, that I will testify, in public court, that the facts stated herein are the truth, the whole truth, and nothing but the truth, so help me God."

- 1. I, James Jones, am a living man, an American National, being a creation of God and domiciled in one of the several states.
- 2. I reserve, claim all, and waive none of my God-given, secured and guaranteed rights, pursuant to the Declaration of Independence and the Constitution for the United States of America, as ratified in 1791

with the Articles of the Amendments.

- I am a living, breathing, sentient being on the land, a natural creation of God, and therefore am not
 and cannot be any ARTIFICIAL PERSON and, therefore, am exempt from any and all identifications,
 treatments, and requirements, as such pursuant to any process, law, code, or statute, or any color
 thereof.
- 4. My Godly origin is fertilization, the moment the Divine spark creates the human zygote, the human zygote being the species specific origin of man; no man can claim to possess the power to create the human zygote, therefore no man can arbitrarily claim ownership of, or authority over, my mind, soul, body, or private property.
- 5. I have never explicitly consented to allow any legal fiction, nor any living man, the ownership or authority over any portion of my mind, soul, body, or private property.
- 6. In these United States for America, the authority of any and all governments resides in the people of the land, for government is a fiction of the mind and can only be created by the people, affected by the people, overseen by the people, for the benefit of the people, and to secure the individual Godgiven rights of the people.
- 7. Pursuant to the above referenced Constitution, Article VI Clause 2, "This Constitution and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, under the authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding".
- 8. As a matter of their lawful compliance to the referenced Constitution, any of the people, while functioning in any public capacity, in return for the trust of the people, are granted limited delegated authority by the people, with specific duties delineated in accordance thereof, shall only do so pursuant to a lawfully designated, sworn and subscribed oath of office and any and all bonds required thereof.
- 9. The only court authorized by the referenced Constitution to hear matters of the people is a court that conforms to and functions in accordance with Article III Section 2 of the referenced Constitution, in which all officers of the court abide by their sworn and subscribed oaths of office and support and defend the Rights of the people, and are heard only in "trial by jury", in accordance with all aspects of due process of law.
- 10. Pursuant to the supreme Law of the Land and the God-given Rights secured and guaranteed therein, this Constitution is established to ensure that the dominion granted by God to all people on this land shall endure, and ensure forever that the people on this land be free from any and all slavery, indentured servitude, tyranny, and oppression under the color of any law, statute, code, policy, procedure, or of any other type.

- 11. Pursuant to this Constitution, I cannot be compelled, manipulated, extorted, tricked, threatened, placed under duress, coerced or so affected, under the color of law by any natural person, who individually, or in any capacity as, or under, any artificial person, agency, entity, officer, or party, into waiving of any of my Rights or to act in contradiction thereof, or to act in opposite of the moral conscience and dominion granted to me by God, nor can I be deprived of any of these Rights, privileges, and immunities, except by lawful process in accordance with the law, without that natural and/or artificial person, in whatever capacity. Anyone using any process, not in accordance with the Constitution, or in non-compliance with due process of law, causing injury to me, thereby commits numerous crimes, requiring lawful punishment therefrom.
- 12. I am not a citizen, resident, subject, taxpayer, et al., of any corporation, no matter how that corporation chooses to classify itself, nor does my physical location or the physical location of my private property create duties and obligations upon me to any corporation, which are fictions of law that cannot make claims against a living man and his private property.
- 13. I am the sole responsible party and holder in due course for all of my private property, including, but not limited to: my mind, soul, body, and any property I have lawfully gained through my labor, labor being defined as "my mental or physical exertion".
- 14. No corporation, no matter how that corporation chooses to classifies itself, can claim any interest in, authority over, or any rights whatsoever, over my mind, soul, body, and private property.
- 15. I am not an expert in the law, however I do know right from wrong. If there is any man damaged by any statements herein, if he will inform me by facts, I will sincerely make every effort to amend my ways. I hereby and herein reserve the right to amend and make amendments to this document as necessary, in order that the truth may be ascertained and proceedings justly determined. If the parties given notice by means of this document have information that would controvert and overcome this Affidavit, please advise me IN WRITTEN AFFIDAVIT FORM, point-for-point, within ten (10) days from receipt hereof, providing me with your counter-affidavit, proving with particularity by stating all requisite actual evidentiary fact and all requisite actual law, and not merely the ultimate facts or conclusions of law, that this Affidavit Statement is substantially and materially false sufficiently to change materially my Status and factual declarations. Your silence stands as consent to, and tacit approval of, the factual declarations herein being established as fact as a matter of law. May the will of our Heavenly Father, through the power and authority of the blood of his Son, be done on Earth as it is in Heaven.
