AFFIDAVIT OF FACT

Before me, the undersigned authority, personally appeared Bethany Cole, who being by me duly sworn, deposed as follows: "I, Bethany Cole, a woman, am over the age of consent, am a creation of God-Almighty and a follower of God's laws first and foremost, and the laws of man when they are not in conflict (Leviticus 18:3,4). Pursuant to Matthew 5:33-37 and James 5:12, let my yea be yea, and my nay be nay, as supported by Federal Public Law 97-280, 96 Stat. 1211 - "Whereas the Bible, the Word of God, has made a unique contribution in shaping the United States as a distinctive and blessed nation and people" and "Whereas Biblical teachings inspired concepts of civil government that are contained in our Declaration of Independence and the Constitution for the United States of America" and "Whereas... the Bible is "the rock on which our Republic rests". I have personal knowledge of the matters stated herein and I have created this Affidavit to establish the true facts of this matter, as this matter lacks the standard of regularity. I declare, under the penalty of perjury and under the laws of the United States for America, that I will testify, in public court, that the facts stated herein are the truth, the whole truth, and nothing but the truth, so help me God."

1. I, Bethany Cole, hereinafter I, me, my, myself, reserve all of my God-given rights, granted by my Creator and secured and protected by the Constitution for the United States of America, hereinafter referred to as "Constitution". I waive no rights, EVER.
2. On October 7, 2021 I was made aware that organizers of the Sullivan Family Benefit Concert have implemented requirements that violate state and federal law and infringe on the rights guaranteed to me and protected by the state and federal constitutions.
3. On October 7, 2021 I emailed Tim Sullivan to confirm these requirements.
4. I received a response on October 7, 2021 from Lorri Sullivan stating that no exceptions would be made to their policy as required for entry to Broadway shows.
5. I have reason to believe that Lorri Sullivan preemptively discriminated against me based upon reading an article I wrote back on July 27, 2020 regarding my personal views.
6. On October 8, 2021 I sent an email back to Lorri Sullivan asking if this benefit was open to anyone who would like to attend. I received no response to my question.

6. On October 22, 2021 I sent a Cease & Desist for Conspiracy Against Rights, Deprivation of Rights Under Color of Law along with a Letter of Intent to Sue via certified mail.
7. I gave them seven (7) days from October 22, 2021 to respond to my Letter of Intent to Sue.
8. The letter was delivered on October 25, 2021.
9. I have reason to believe Tim Sullivan, Lorri Sullivan and Claudine McAnelly intentionally ignored my Letter of Intent to Sue.
10. On November 2, 2021 I emailed Tim Sullivan, requesting to purchase two (2) \$100 tickets for the show on November 6, 2021.
11. On November 3, 2021 Lorri Sullivan responded that the tickets for this benefit were indeed sold out.
12. I have reason to believe that Tim Sullivan, Lorri Sullivan and Claudine Sullivan intentionally ignored my requests and delayed their response until the tickets were sold out.
